

## Terms of Service for Beezonia's SaaS Services

Welcome to Beezonia's SaaS Services. These terms of service ("Terms") govern your access to and use of our SaaS software and services ("Services"). By accessing or using any part of the Services, you agree to be bound by these Terms.

### 1. Acceptance of Terms

By registering for and/or using the Services in any manner, including but not limited to visiting or browsing the site, you agree to all of the terms and conditions contained herein.

### 2. Service Description

Beezonia's SaaS Services provides a Trading / Linklist Software with review System.

### 3. User Registration and Account Integrity

You must register for and maintain an active personal user Services account ('Account').

A valid payment method, including credit card, is required to process the payment for your Subscription. You shall provide Beezonia with accurate and complete billing information including full name, address, state, zip code, telephone number, and a valid payment method information.

Prices for using the Services may change upon 30 days' notice from us. Such notice may be provided at any time by posting the changes to the Beezonia's site or the Service itself.

Beezoniam reserves the right at any time to modify or discontinue, temporarily or permanently, the Service (or any part thereof) with or without notice.
